ARI's partnerships in this effort continue to include families, clinicians, and researchers around the globe. 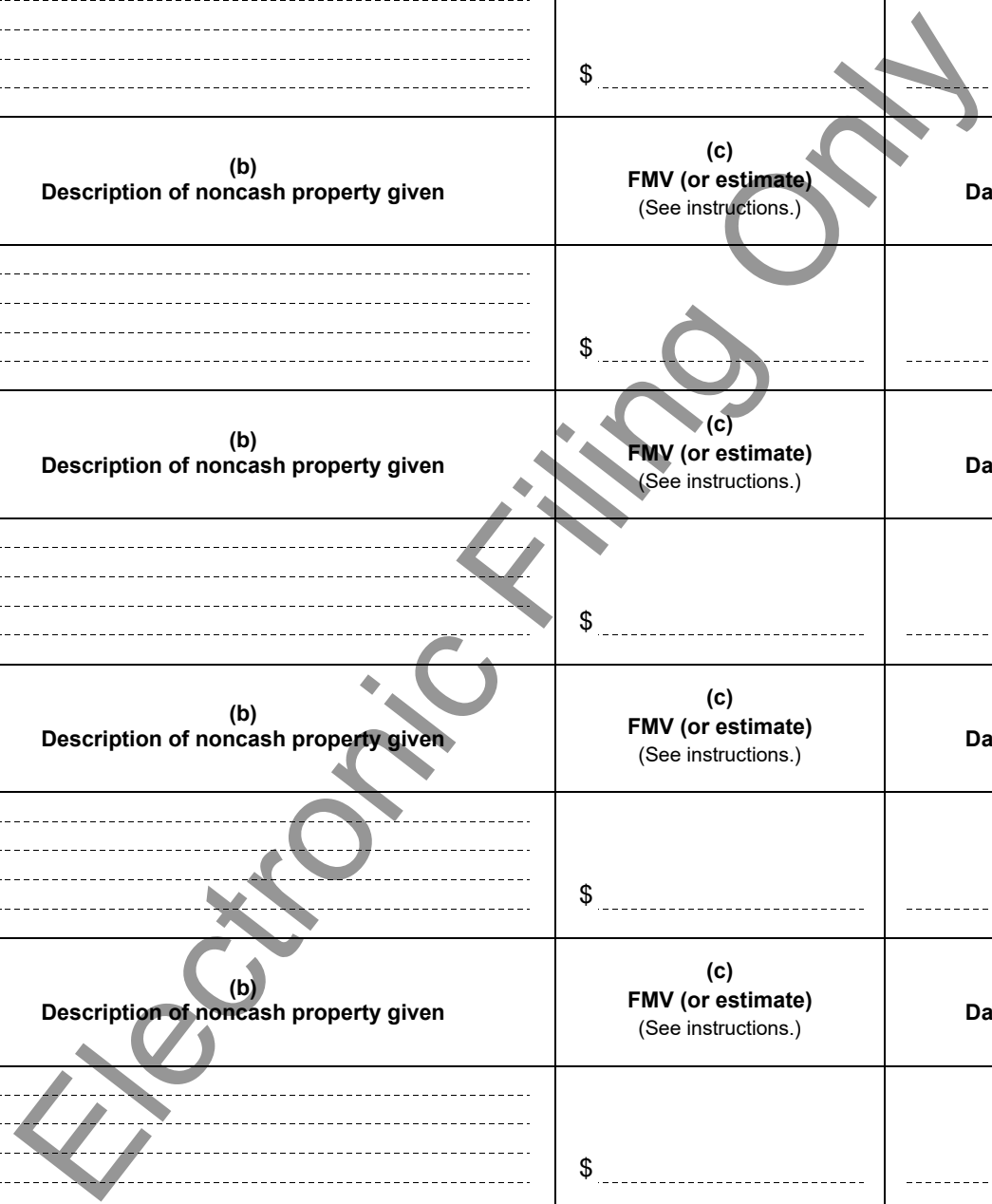
