This includes (1) conducting research, (2) organizing national and regional think tanks, (3) sponsoring near weekly webinars, (4) offering, in joint providership with the Cleveland Clinic, complimentary AMA PRA Category1 Credit to physicians, (5) sponsoring a popular website, www.autism.org, (6) producing informative videos, and (7) publishing e-newsletters, a hardcopy quarterly science newsletter, and multidisciplinary books.

4b (Code:) (Expenses \$ 302,654 including grants of \$) (Revenue \$) The Autism Research Institute (ARI) has awarded research grants to scientific investigators worldwide. ARI prides itself in funding "research that makes a difference." The funded research is aimed at investigating the underlying causes of autism including biochemistry and neurology as well as developing and validating treatment effectiveness. ARI supports two major autism tissue banks including the National Institute of Child Health and Human Development at the University of Maryland and the gastrointestinal autism tissue bank at Massachusetts General Hospital. Much of ARI's funded research is focused on examining the gastrointestinal, immune, and metabolic systems.

4c (Code:) (Expenses \$ 6,000 including grants of \$) (Revenue \$) The autism research institute (ARI) is an ngo member of the United Nations. ARI collaborates with researchers, organizes conferences and think tanks, and actively consults with autism organizations worldwide. Many of our articles, videos, and assessment questionnaires have been translated into various languages in the past years, ARI provides outreach services to families and professionals in 77 countries.

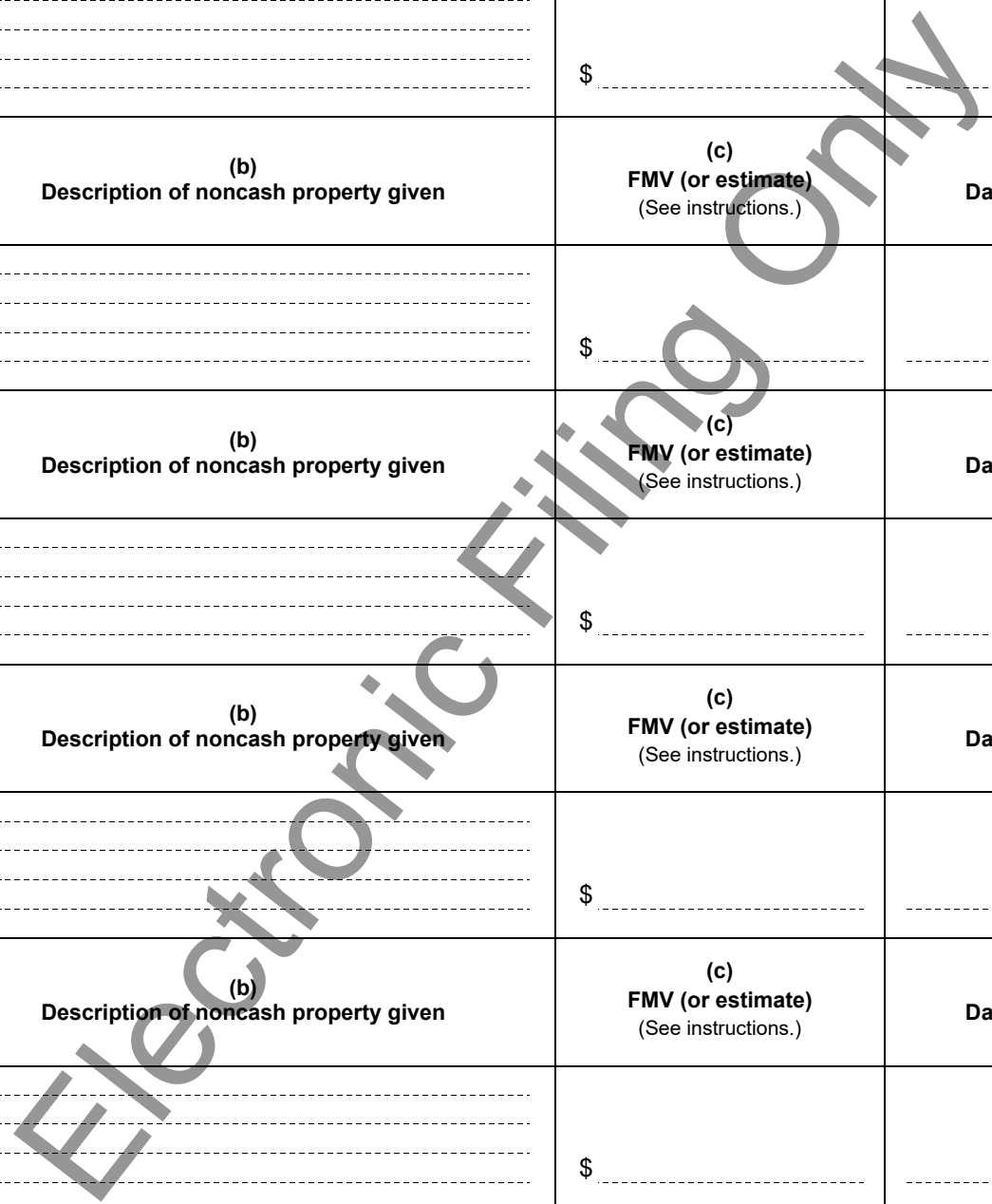
