THE FUNDED RESEARCH IS AIMED AT INVESTIGATING THE UNDERLYING CAUSES OF AUTISM INCLUDING BIOCHEMISTRY AND NEUROLOGY AS WELL AS DEVELOPING AND VALIDATING TREATMENT EFFECTIVENESS. ARI SUPPORTS TWO MAJOR AUTISM TISSUE BANKS INCLUDING THE NATIONAL INSTITUTE OF CHILD HEALTH AND HUMAN DEVELOPMENT AT THE UNIVERSITY OF MARYLAND AND THE GASTROINTESTINAL AUTISM TISSUE BANK AT MASSACHUSETTS GENERAL HOSPITAL. MUCH OF THE FUNDED RESEARCH INVESTIGATES COMMON MEDICAL PROBLEMS, SUCH AS THEIR COMPROMISED GASTROINTESTINAL, IMMUNE, AND METABOLIC SYSTEMS. IN ADDITION, FUNDING IS AWARDED TO RESEARCH VALIDATING SENSORY-BASED INTERVENTIONS INVOLVING HEARING, TACTILE, AND VISION.

THE AUTISM RESEARCH INSTITUTE HOUSES AND FUNDS THE GLOBAL AUTISM COLLABORATION CONSISTING OF OVER 120 NON-PROFIT AUTISM ORGANIZATIONS WORLDWIDE INCLUDING AUSTRALIA, BARBADOS, BRAZIL, CHILE, DUBAI, ETHIOPIA, FRANCE, INDIA, ITALY, JAPAN, NIGERIA, PUERTO RICO, AND MANY MORE. GAC HAS SPONSORED MANY CONFERENCES AND OUTREACH SERVICES. IN THE PAST TWO YEARS, THIS HAS INCLUDED COLUMBIA, GHANA, INDIA, THE PHILIPPINES, RUSSIA, AND THE UKRAINE.
